

PERMIT TO CARRY APPLICATION INSTRUCTIONS

WHAT YOU NEED TO KNOW

- 1. Applications will be accepted **<u>BY APPOINTMENT ONLY</u>**
- 2. You must be a New Jersey Firearms ID Card Holder.
- 3. The instructions are the same, whether this is an Initial Application or a Renewal Application.
- 4. This is a paper Application and you MUST APPLY IN PERSON (BY APPOINTMENT ONLY)
- 5. All armored car guard applications shall be submitted to the appropriate New Jersey State Police Barracks
- 6. All other (non-armored car guards) shall be submitted to the Law Enforcement Agency where the applicant resides. If your town of residence is covered by a New Jersey State Police barracks on a full-time basis, please submit your application to that barracks.
- 7. All Applicants must be fingerprinted for initial or renewal applications. Applicants can visit IdentoGO <u>https://uenroll.identogo.com/</u> to schedule an appointment.
 - A. When scheduling your appointment, use Service Code: 2F164B
 - B. Use ORI#: NJ0030500 for Burlington City
 - C. For Contributor's case number use applicants last name, month, day and year of birth (example: Smith01011990 = Smith January 1, 1990)
- 8. A consent for Mental Health Search Form (S.P. 066) <u>will be provided</u> at your appointment to turn in the application. <u>This form must be signed in the presence of a police</u> <u>representative.</u>

AT THE TIME OF APPLICATION APPOINTMENT YOU MUST PROVIDE THE FOLLOWING

- Driver's License and Birth Certificate **OR** Drivers License and Passport **OR** Driver's License and Naturalization Paperwork/Green card
- Three (3) State of New Jersey Applications ORIGINAL COPIES for Permit to Carry a Handgun (form S.P. 642 <u>https://nj.gov/njsp/firearms/pdf/sp-642.pdf</u> MUST BE DOUBLE SIDED AND NOTARIZED)
- □ Four **(4)** color passport size photographs (2"x2")
- □ Written proof of ownership:
 - A. Proof of ownership can be a purchase receipt or purchase permit **OR** a notarized letter of ownership listing the make, model and serial number of the handgun(s).
- □ Written proof of qualification with the handgun(s) you intend on carrying:
 - A. Written qualification must be within six (6) months of application and must include: Instructor's name, Certification Number, Make, Model, Caliber and serial number of the handgun(s) <u>you intend to carry</u>. The required written Firearms Qualification, in accordance with N.J.AC. 13:54-2.4(B), can be obtained at most Firearms Ranges throughout the State. - □ Money order in the amount of \$50.00 payable to "Treasurer, State of New Jersey".
- □ IdentoGO Receipt from Fingerprinting:
 - A. Fingerprints must be completed and results received within ninety (90) days of your Application appointment.
